

Rental Bicycle Damage Cost Reduction Protection Program

Dirt Gypsy Adventures offers the following damage cost protections to our renters. Damage cost reduction protection may be selected for all or none of bikes that make up your reservation and the program is subject to the following conditions:

- I acknowledge that all damage amounts are calculated based on retail prices and include both parts and labor
- I acknowledge that rented equipment may not be taken to Northstar for lift-access or bike-park use and that doing so will make my election for this damage cost reduction protection program invalid
- I acknowledge that the first \$100 of damages in retail repair costs of parts and labor shall be covered on all damaged items as determined by the repair technician who evaluates the bike's condition upon its return
- I acknowledge that on damages and the required associated repairs with a retail cost of \$101-\$500 that I shall be liable for 40% of the repair cost of items deemed damaged by the repair technician evaluating the bike's condition upon its return. Credit for the first \$100 of damages is not included. (Example: \$400 repair to replace damaged carbon swingarm due to a crash = \$160 repair charge owed by customer)
- I acknowledge that on damages and the required associated repairs with a retail cost of \$501-\$2000 that I shall be liable for 50% of the repair cost of items deemed damaged by the repair technician evaluating the bike's condition upon its return. Credit for the first \$100 of damages is not included. (Example: \$900 repair to replace broken suspension fork due to a crash = \$450 repair charge owed by customer)
- I acknowledge that should a total loss of the bicycle occur, due to any circumstance, while the bike is in my possession this damage cost reduction protection shall be secondary to other insurance coverage owned by me that may cover the cost of replacement subject to that insurance provider's conditions for a claim. Should no coverage be available from another insurance provider this damage cost reduction protection shall allow for a replacement of the bicycle as a total loss at the current retail price for the same model of bicycle. This total loss amount will be determined by our affiliate shop and bike supplier, Start Haus, on the date of the notification of the loss
- I acknowledge that this is not an insurance product. It has not been evaluated by any governmental body and is not endorsed by any governmental agency. This is a contract with the owners of the bicycle that I rented, and its purpose is to reduce potential future retail priced damage charges. If I decline this protection program offered by Dirt Gypsy Adventures I am liable for any and all retail damage charges of the rental bicycles while in my possession
- I acknowledge that rented bikes may not be examined immediately upon return and that Dirt Gypsy Adventures has up to 8 hours to inform me of any damages
- I acknowledge that it is my responsibility to communicate if there are any damages to the rented equipment upon return
- **I acknowledge the fee for this damage cost protection is \$7 per rental day per bicycle**
